The following are the highlights of the brief terms & conditions.

1. The lowest quoted rate/ tender will be selected by the competent authority/ Building sub-committee.
2. The offered rates are negotiable. The rate quoted by the tenderers will be **including G.S.T.**
3. Standard/ Premium quality materials be used.
4. The Work must be completed within 06 months from the date of allotment of the said work.
5. Sealed quotations be sent to the Headmistress, DAV Public School, Chakandra More, Chewara Road, Sheikhpura (Bihar), Pin Code- 811304.
6. Drawing, design and specifications provided by the Architect should be studied properly before submitting the bid (**technical bid and financial bid**).
7. Account payee Cheque of Rs. 2.5 lacs in the name of DAV Public School, Sheikhpura (a unit of DAV College Trust & Management Society) be submitted along with the Financial Bid as earnest money. The earnest money Cheque will be returned to all the tenderers except the **L1** who will be awarded the tender.

9. Interested parties are requested to visit DAV Public School, Chakandra More, Chewara Road, Sheikhpura (Bihar) site if they wish, before quoting the rates.
10. Technical bid should be submitted on or **before 26/04/2024** through email constructiondavsheikhpura@gmail.com
11. Information regarding selection and rejection of technical bid will be intimated through mail.
12. Last date for submitting the sealed financial bid (By post or by Hand) will be **28/04/2024**. After that no entry will be accepted.
13. The financial bid will be opened on 29/04/2024 at Regional Office, DAV Public Schools, Bihar Zone-D, C/o BR DAV Public School, Refinery Township, (IOCL), Begusarai at 11:30 a.m.
14. The competent authority/ Building Sub-Committee reserves the right to accept or reject any of the tenders without assigning any reason.
15. All payments by the employer under the contract/ agreement will be made by mutual understanding on submission of running bill and has to be approved by the designated Architect.
16. The defect and liability period shall be for 12 months. 10% of final approved bill amount of the contractors shall be retained as retention money upto 12 months from the date of handing over of the building. However, 10% of retention money will be deducted as each approved running bill.
17. The terms & conditions are mentioned in the Tender Documents which has to be strictly adhered too.
